


Dumping occurs when an exporter/producer sells a product for export to the importing country:

- i. at a price lower than the price at which the same (or similar/like) product is sold in its own domestic market. OR
- ii. at a price less than its cost to make and sell.

Dumping is unfair trade practice and trade defense laws of WTO permit an Authority of the importing country to impose antidumping duties with a view to offset the injurious effects of dumping on the domestic industry.
